

CONTINGENT FEE AGREEMENT

Re: Litigation against Robert A. Baffert, Bob Baffert Racing Stables, Inc., and Zedan Racing Stables, Inc.

The undersigned ("Client") engages William B. Federman of Federman & Sherwood ("Attorney") and Daniel P. Markoff of Atkins Markoff Adler Law ("Attorney") to seek damages from Robert A. Baffert, Bob Baffert Racing Stables, Inc., and Zedan Racing Stables, Inc. ("Defendants") and to institute litigation against Defendants and anyone else believed by the Attorney to be liable. Client agrees that Attorneys may associate with other law firms, experts or consultants in prosecution of this litigation.

For their services, Attorneys agree to accept the engagement on a contingency basis. Attorney will be responsible for all expenses, which may include, but are not limited to, filing fees, costs of travel, lodging, copying, telephone calls, postage, depositions and expert witness fees. Reimbursement of all expenses advanced by Attorneys, or payment of expenses made on Attorney's behalf, will be made before distribution of the net proceeds of any recovery. If a class is certified, Attorney will receive fees as approved and ordered by the Court. If a class is not certified and Client's action is settled, Attorneys will receive 40% of all value received, or as ordered by the Court, or as agreed to by the parties. If no recovery is made, Client will not be responsible for Attorneys' fees or any expenses paid by Attorneys. Attorneys are not required to pursue any appeals.

Client grants Attorneys an Attorney's Lien on any recovery in this matter. Any disputes under this agreement shall be resolved by binding arbitration in Oklahoma City, pursuant to the rules of the American Arbitration Association for commercial arbitration.
